

Class Size Reduction Q&A

Brevard Public Schools' Class Size Amendment K-12 Strategies

Elementary Schools

- The Board provided a .5 unit to each school to assist with their elementary art program.
- Multi-Age Classroom Formation
- Dual certified exceptional education teacher to basic classroom (serving Exceptional Education students and basic students
- Science lab teacher to basic classroom

Middle Schools

- The Board provided 6 of 7 supplements for teachers for core class overages.
- Some middle schools will have an additional Math teacher working between mesh teams to accommodate Algebra/Geometry classes in order to alleviate large class size in general math.
- Increase numbers in all non-core academics and electives.

Senior High Schools

The Board provided 6 of 7 supplements for teachers for core class overages.

- The Board provided 6 of 7 supplements for teachers for elective class student enrollment (Driver Education).
- Increase class size in non-core academics and electives.
- Change to a fourth credit requirement in Science and/or Social Studies.
- Combine classes such as Chorus and Drama or Year Book and Newspaper.

Out-of Area

- Denial of out-of-area applications.
- Following six-day count, the district will review requests and make adjustments where needed based on class size amendment requirements.

History of Florida's Class Size Amendment

In 2002, citizens approved an amendment to the Florida Constitution that set limits on the number of students in core classes (such as Math, English, Science, etc.) in the state's public schools. Beginning with the 2010-2011 school year, the maximum number of students in each core class would be:

- 18 students in prekindergarten through grade 3;
- 22 students in grades 4 through 8; and
- 25 students in grades 9 through 12.

In 2003, the Florida Legislature enacted Senate Bill 30-A that implemented the amendment by requiring the number of students in each classroom be reduced by at least two students per year beginning in the 2003-04 school year, until the maximum number of students per classroom did not exceed the requirements in

law. The amendment would be calculated as follows:

- 2003-2004, 2004-2005 and 2005-2006 at the district level
- 2006-2007 and 2008-2009 at the school level
- The 2009 Legislature extended the calculation at the school level for an additional year to include 2009-2010.
- 2010-2011 at the classroom level

Florida's Class Size Amendment - 2010 Legislative Session

In 2010, the Florida Legislature approved a constitutional amendment to be placed on the ballot that will ask voters to change the state constitution's current maximum class sizes to "school-wide average class sizes." If the amendment is approved by voters, maximum class size would be calculated based on the school-wide average of the number of students in core classes assigned to each teacher beginning with the 2010-2011 school year and be:

- 18 students in prekindergarten through grade 3;
- 22 students in grades 4 through 8; and
- 25 students in grades 9 through 12.

In addition, the proposed change to the constitution would set the maximum number of students assigned to each teacher, while not exceeding the school-wide average, to be:

- 21 students in prekindergarten through grade 3;
- 27 students in grades 4 through 8; and
- 30 students in grades 9 through 12.

Class Size Implementation Budget

To date, the Florida Legislature has appropriated more than \$16 billion toward operational expenses and \$2.5 billion in facilities funding to implement the Class Size Amendment. Below are the funding amounts for each category since the amendment was put into law.

Consequences of Not Meeting Class Size Requirements

Financial penalties are assessed on school districts who do not meet class size amendment requirements. The FLDOE will redistribute the funds collected from these penalties to districts that have fully met the class size requirements.
