2014-2015 SALARY SCHEDULE

All newly hired teachers with a Bachelor's degree and no prior experience will be placed at the Bachelor's Degree level and 2 years of experience. All newly hired teachers with a Bachelor's plus (150 semester hours or more but less than a Masters) shall be paid the BA and 2 years rate. **Teachers are paid for years completed,** and shall move to the next step after completing 3 years. Adjustments will be made upon receipt of official verification of degree(s) or coursework with original college transcripts, years of prior teaching experience, up to 10 years*.

Effective August 20, 2012 through May 30, 2014, Teachers and other CEA bargaining unit professionals shall be paid in accordance with the following:

^{*} A "year" shall consist of at least 120 days for at least 7 hours per day during a school year. Public school teaching experience shall include teaching experience in all public schools, accredited armed forces U.S. State Department Dependency Schools, Peace Corps, and VISTA. Service credit may be given to physical therapists, school social workers, nurses, occupational therapists, and speech therapists for full time (40 hrs /wk) private employment. Up to 10 years military experience shall be granted upon receipt of documentation (DD-214) indicating actual years of active service. Teachers hired with a Trades & Industries certificate who are initially employed to teach under such certificate, shall be granted credit for years of experience outside the Columbus City School District for salary purposes, up to a maximum of 5 years. Up to ten (10) years experience credit for vocational teachers shall be given based upon documented other related employment or related self-employment. Rev 5/12
