Political Action Committees ("PACs"): The NEA Fund for Children and Public Education ("NEA FCPE"), the WEAC Political Action Committee ("WEAC PAC") and the Milwaukee Teachers' Education Association Political Action Committee ("MTEA PAC") are political action committees funded solely by voluntary member contributions—not dues—including small amounts, published annually, that by default are included with dues in the member payments described above. Both NEA FCPE and WEAC PAC use contributions primarily for making contributions to and expenditures on behalf of candidates for federal and state office, while MTEA PAC uses contributions primarily for making contributions to and expenditures on behalf of candidates for federal and state office, while MTEA PAC uses contributions primarily for making contributions to and expenditures on behalf of candidates for federal and state office, while MTEA PAC uses contributions in ot a condition of membership in the NEA or any of its affiliates, and members have the right to refuse to contribute without suffering any reprisal. I may contribute more or less than the suggested amount, or may contribute nothing at all, without it affecting my membership status, rights, or benefits. The NEA FCPE, WEAC PAC and MTEA PAC are subject to regulation by the Federal Election Commission and the Wisconsin Ethics Commission. Federal law requires the NEA FCPE to use their best efforts to collect and report the name, mailing address, occupation, and name of employer for each individual whose contributors aggregate in excess of \$200 in a calendar year.

Political Action Rebate: I may request a refund of that portion of my payment designated for WEAC/NEA political activity by writing to WEAC, PO Box 8003, Madison, WI 53708 between Sept. 1 and Oct. 30, or within 60 days of joining. Once I request a WEAC PAC rebate, no WEAC PAC payments will be drawn in future membership years unless I specifically request in writing to reinstate WEAC PAC participation. I may annually request a refund for that portion of my payment designated for MEAC/NEA political activity by writing to reinstate WEAC PAC participation. I may annually request a refund for that portion of my payment designated for MTEA political activity by sending a signed, written request to MTEA, 5130 W Vliet St, Milwaukee, WI 53208, each year before Oct. 1. My memberships will not be affected by a request for refund.

EFT Dues and PAC Withdrawal Authorization: To facilitate my payment of annual dues and any additional PAC contribution I choose to make, I hereby authorize MTEA or WEAC—whichever organization the Executive Board of MTEA, at its sole discretion, determines can do so most efficiently—to initiate Electronic Funds Transfers (EFTs) from the bank account described below. The annual dues for the current membership year and each year thereafter shall be withdrawn starting on the first full payday in September. The amount of my bimonthly payment is my annual dues obligation divided by 20 pay periods (Sept. - June), unless MTEA has selected a different dues payment schedule. My authorization is in full force and effective until I terminate this agreement by notifying MTEA in writing. I understand my written notification to MTEA must be made by the 1st day of the month in order for this agreement to be terminated or changed in any manner for the following month. I further agree that if any such withdrawal is dishonored with cause, MTEA shall be under no liability whatsoever if such dishonor results in late charges or fees.

Dues payments are not tax deductible as charitable contributions for federal income tax purposes. However, they may be tax deductible as ordinary and necessary business expenses. Contributions to PACs are not tax deductible. I am attaching a VOIDED CHECK for verification of bank information.
