Guidelines for Credit Given for Prior Experience

<u>Teachers, Counselors, School Psychologists, Occupational Therapists, Physical Therapists and Speech Language</u> <u>Pathologists:</u>

- Full-time satisfactory teaching experience as a lead teacher will be accepted for teachers.
- Full-time satisfactory psychology experience will be accepted for school psychologists.
- Full-time satisfactory occupational therapy experience will be accepted for occupational therapists.
- Full-time satisfactory speech language pathology experience will be accepted for speech language pathologists.
- Satisfactory Experience as a full-time counselor in a school or as a counselor in a public or private youth agency is acceptable for prior experience credit for school counselors.
- Part-time and shared time teaching, student teaching, or serving as a teacher's assistant, teacher's aide, per diem substitute, or other similar positions will not be accepted for prior experience credit.
- A full-year of prior experience credit will be given if an individual worked for 75% of the school year in
 the same school district. The year can either be a 10-month or 12-month position. 75% of a 10-month
 position is equivalent to at least 135 days or 7.5 months. For example, if a school year is from September
 1 to June 15 and an individual held a position from October 15 until the end of the school year, the
 individual would receive prior experience credit for a full-year because she/he worked for more than 75%
 of the work year.
- Long-term substitute positions that were held for seventy (70) days or more in a semester will be given a half-year of prior experience credit. Half-years of long-term substitute teaching credit will be counted as full years of prior experience credit if there are an even number of half-years. If there is an odd number of half-years, credit will be rounded down to the closest half-year. For example, two half-years of long-term substitute teaching credit will be counted as a full year. Three half-years of long-term substitute teaching credit will be rounded down to the closest half-year and counted as a full year.
- Satisfactory experience will only be counted if it is after the awarding of a bachelor's degree. Experience prior to a bachelor's degree will not be credited.
- Satisfactory experience will be accepted at any education level including pre-school, elementary, secondary, community college, or college/university level; and through any accredited or licensed educational entity, including public school, private school, parochial school, day care center or program, charter school, or college/university.
- Credit will be given for years minus one, with a maximum placement of step ten on the Teacher Scale.
- Verification received within 60 days of appointment will be retroactive to the date of appointment. Experience received after 60 days will not be retroactive.

Placement on a higher salary scale than bachelors requires an official sealed transcript. Please note that the Office of Certification will only accept official sealed transcripts reflecting conferred or awarded degrees. Guidelines for Credit Given for Prior Experience

Nurses

- Credit will be given for registered school nurses who have satisfactory experience as a registered nurse or higher acting in a capacity providing direct care to patients.
- Nurses will receive prior experience credit based on the hours they worked weekly, bi-weekly, monthly or yearly:
 - A full year of prior experience credit will be given for 30 hours per week or more, 60 hours biweekly or more, 120 hours monthly or more, or 1,440 hours annually or more.
 - o A half-year of prior experience credit will be given for 20-29 hours per week, 40-59 hours biweekly, 80-119 hours monthly or 960-1,439 hours annually.
- Half-years of prior experience credit will be combined to give credit as full years of prior experience credit if there are an even number of half-years. If there are an odd number of half-years, credit will be rounded down to the closest half-year. For example, two half-years of prior experience credit will be combined to make a full year. Five half-years of long-term prior experience credit will be rounded down to the closest full year and counted as two full years.
- Verification received within 60 days of appointment will be retroactive to the date of appointment. Experience received after 60 days will not be retroactive.
- Credit will be given for years minus one, with a maximum placement of step ten.

Vocational/CTE Teachers

- Vocational teachers will receive prior experience credit for satisfactory industry experience in the subject area they are teaching based on the hours they worked per week:
- Full-time prior experience credit will be given if the individual worked a minimum of 30 hours per week or
- Part-time prior experience credit will be given if the individual worked 20-29 hours per week. Part-time prior experience credit will be counted as half-years. For example, 5 years of part-time experience will be counted as 2.5 years of full-time experience.
- Months of part-time and full-time work will be added together. Any remaining partial years that cannot be added together to equate one year of credit will not be counted.
- Vocational teachers who hold a bachelor's degree must submit an official sealed transcript to effect your salary.
- Verification received within 60 days of appointment will be retroactive to the date of appointment. Experience received after 60 days will not be retroactive.
- Credit will be given for years minus one, with a maximum placement of step ten.

Placement on a higher salary scale than bachelors requires an official sealed transcript. Please note that the Office of Certification will only accept official sealed transcripts reflecting conferred or awarded degrees.
