Sick Leave Hourly Allocations

- In order to be consistent with the real time hours worked by employees not on an 8 hour work day, SBTA worked with the district to adjust the daily allocation of hours for 1 day of sick leave from 6 to 7.
- The total number of hours on the pay warrants should reflect the same number of days
 previously accrued when divided by 7 and not 6 per day. This adjustment was made starting
 July 1, 2018.
- If employees are putting in for 1/2 day of leave, the amount of sick leave deducted will now be 3.5 hrs instead of 3. This matches up more accurately with the real time of the work day for teachers, which is already at 7 hours per day. There was <u>NO</u> increase in working hours to the work day.
- There is no change in the number of days of sick leave that employees accrue each year as that is dictated by Ed Code and the SBTA/SBCUSD Collective Bargaining Agreement under Article XX Section 1.

Check Your Paychecks

The contract, Appendix B, states that "Unit members have an obligation to exercise due diligence by checking their pay warrants to insure that their salary placement is correct. Errors ... in an underpayment ... will be corrected. The unit member will receive from the District the amount of underpayment, not to exceed one year of underpayment."

You also need to check your sick leave and make sure it is correct. The district will only correct up to one year for that as well.

Dues

Your union dues are a combination of SBTA, CTA and NEA. SBTA Rep Council votes on SBTA dues when they adopt the annual budget. The dues are based on a formula prescribed by the SBTA Bylaws. The dues schedule for the 2018-19 membership year for SBTA, CTA and NEA is printed on the back of this update for your reference.
